Ken Skates, AM, had also recently commissioned a traffic study across the three counties of Chester/Cheshire West, Wrexham and Flintshire and this article could have had a detrimental effect to the campaign as it had implied that Welsh Government had stalled the plans.

The Chair requested that Ken Skates be invited to visit the area by the Community Council and that the Council act together with local residents and businesses to lobby Welsh Government for these much-needed improvements.

A heated exchange of views took place between members about the process that should have been followed and that some Councillors had withheld vital information about the petition. Councillors Billy Mullin and Ryan McKeown reminded Members that the Community Council and the three County Members had actively pursued this matter over the years and that a solution needed to be implemented.

Councillor Donna Lalek expressed her disappointment that the article appeared to put forward a view of the Community Council and that the petition had not been shared or discussed with Council members and that it would have been "decent and respectful" for members to have shared this information earlier.
