

1. APPOINTMENT OF CHAIR:

Councillor Ros Griffiths was nominated to act as Chairman, this was duly seconded and agreed and **IT WAS RESOLVED:** that Councillor Ros Griffiths be appointed Chairman for the meeting.

2. APOLOGIES FOR ABSENCE:

Apologies for absence had been received from Councillors Darren Sterry (HCC) and Connor Wynne (HCC).

3. MINUTES OF THE PREVIOUS MEETING:

The minutes of the previous meeting held on 25th November 2025, copies of which had been circulated with the agenda, were received and approved as a correct record.

4. MATTERS ARISING FROM THE MINUTES:

There were none.

5. JOINT SERVICES:

The Chairman referred members to the comprehensive report that had been circulated with the agenda for the meeting. The report outlined the budget position for 2025/26 and the proposals for 2026/27. A 5% increase on salaries had been budgeted for together with inflationary increases.

The Clerk and Financial Officer for Hawarden and Broughton and Bretton Councils had recently been awarded her BA (Hons) Degree in Community Governance following six years of study. She wished to place on record her thanks to all three council's for supporting her with this qualification.

The Clerk provided an update on the street lighting contract for all three councils. As members had been aware, the contract with Southern Scottish Energy (SSE) had expired on the 31st March 2025 and it had been agreed to combine the council's contract with Flintshire County Council. However, this process had been delayed by SSE and discussions had subsequently been held with Crown Commercial Services (CCS) who provided its energy to Flintshire County Council. This new arrangement should be in place by 1st April 2026 with a similar level of efficiencies previously agreed.

Members thanked the Clerk for the production of this comprehensive report.

IT WAS RESOLVED: that the budget report be received and noted.

6. STREET LIGHTING – LED HEAD REPLACEMENT SCHEME:

The Clerk and Financial Officer had circulated an updated report on the number of LED Head replacements, per ward. Although the LED replacement programme was nearing its conclusion, the Council's Maintenance Team would now start to renew the old concrete columns.

IT WAS RESOLVED: to note the update.

7. SERVICE LEVEL AGREEMENTS:

The Service Level Agreements (SLAs) had been circulated and approved with no amendments. Arrangements would be made to have them physically signed in due course.

IT WAS RESOLVED: to agree the current SLAs.

8. DATE OF NEXT MEETING:

The next mid-year review meeting would take place in October/November 2026.

The meeting concluded at 5.11 p.m.

Planning enforcement plays an important role in maintaining confidence in the planning system, protecting the built and natural environment, and ensuring development takes place in accordance with planning legislation and policy. The Draft Policy sets out how the Council will investigate alleged breaches of planning control, how cases will be prioritised, and the range of actions that may be taken where it is considered expedient to do so.

The Council is seeking views from residents, Town and Community Councils, businesses, developers, and other interested stakeholders on the Draft Policy before it is finalised.

Please note that this consultation is about the Draft Planning Enforcement Policy, not about individual enforcement cases.

Community Reviews under the Local Government (Democracy) (Wales) Act 2025 – Draft Proposals

Foreword

Draft Proposals for the Communities of Flintshire County Council

This report presents our draft proposals for the communities within the county of Flintshire. The review has been carried out in accordance with the Local Government (Democracy) (Wales) Act 2013 and the Council's Terms of Reference.

Fairness is a central principle embedded in the legislation and has guided the Council throughout this process. In line with our statutory obligations, we have also considered future developments and obtained five-year electorate projections.

In formulating these proposals, we have taken into account local connections and the views of those advocating for the retention of existing boundaries. Every representation submitted has been carefully reviewed. However, these considerations have had to be balanced against other statutory factors and constraints, particularly the need to ensure that communities continue to reflect local identities and support effective and convenient local governance. Where changes to community or ward boundaries are proposed, the Council has also considered the importance of electoral parity and democratic fairness for all electors.

We appreciate the contributions made by town and community councils, as well as all individuals and organisations who submitted representations. We welcome any feedback or views you may wish to share on these draft proposals.

1. Summary of Draft Proposals

- 1.1 As a principal council, Flintshire County Council is undertaking Community Reviews under sections 25 and 31 of the Local Government (Democracy) (Wales) Act 2013 ("the Act"). The Terms of Reference for the review can be found on the Council's website.
- 1.2 Flintshire has considered whether it needs to make revisions to the structure of communities and community wards to ensure that
 - i. local identities are preserved and
 - ii. the arrangements continue to support effective and convenient local governance across the principal council area.
- 1.3 The Council has proposed amendments to the boundaries of two town council wards within the town of Connah's Quay, and would like to receive further observations on proposals made by Cilcain Community Council and Penyffordd Community Council.
- 1.4 The Council has also proposed amendments to the electoral arrangements (i.e. the number of councillors per ward) for Flint Town Council, Hawarden Community Council and Sealand Community Council and would like to receive further observations in respect of the different options identified for Bagillt Community Council and Saltney Town Council.

2. Council Size

- 2.1 The table below sets out the Town/Community Council size ratio of councillors to electors to be used as a flexible guide:

Community ward boundary proposals

The Council proposes no changes to the community ward boundary.

Community Council electoral arrangements

The Council welcomes observations on the following two options:

1. The Council proposes that the Community Council's warding arrangements should be removed. This would follow the Principal Council's warding arrangements.
2. The Council proposes no change to the Community Council's electoral arrangements.

The Council proposes no changes to the number of community councillors.

Proposed Name

The Council proposes to retain the English/Welsh community name of Bagillt.

5.3 Broughton and Bretton Community Council

The current community arrangements in Broughton and Bretton consist of two wards: North East and South. The community has a total electorate of 5,162 and is represented by 14 community councillors. The electorate per ward and the number of councillors are as follows:
